On contractive cyclic fuzzy maps in metric spaces and some related results on fuzzy best proximity points and fuzzy fixed points

Abstract

This paper investigates some properties of cyclic fuzzy maps in metric spaces. The convergence of distances as well as that of sequences being generated as iterates defined by a class of contractive cyclic fuzzy mapping to fuzzy best proximity points of (non-necessarily intersecting adjacent subsets) of the cyclic disposal is studied. An extension is given for the case when the images of the points of a class of contractive cyclic fuzzy mappings restricted to a particular subset of the cyclic disposal are allowed to lie either in the same subset or in its next adjacent one.

Keywords: fixed and best proximity points; fuzzy cyclic contractive maps; cyclic fuzzy contraction and fuzzy sets

1 Introduction

Fixed point theory has received much attention in the last decades with a rapidly increasing number of related theorems on nonexpansive and on contractive mappings, variational inequalities, optimization *etc.* Variants and extensions have also been considered in the frameworks of probabilistic metric spaces and multivalued mappings. The wide variety of problems of cyclic and proximal contractions has also received much attention in the last years.

Fixed point theory has also proved to be an important tool for the study of relevant problems in science and engineering concerning local and global stability, asymptotic stability, stabilization, convergence of trajectories and sequences to equilibrium points [1–3], dynamics switching in dynamic systems and in differential/difference equations, *etc.* In particular, the equilibrium problems associated with switching processes in dynamic systems [1–4] are sometimes related to cyclic mappings where the cyclic disposal contains either trajectory solutions or sequences which commute to adjacent subsets being appropriately defined. Cyclic mappings, related contractive properties, and best proximity points have been widely studied in metric spaces in both the deterministic [5–10] and the probabilistic frameworks, see, for instance, [11–14], as well the related proximal-type problems, see, for instance, [15, 16] and references therein.

The concept of fuzzy contractions was proposed in [17] and has been revisited later on in [18–21] including the study the common fixed points and compatibility problems in fuzzy metric spaces, [22–28]. In particular the paper by Azam and Beg [22] is very

illustrative and well worked out on a set of proved properties associated with a very general fuzzy contractive condition. On the other hand, a fuzzy theory related to the more general intuitionistic fuzzy metric spaces is also being developed. See, for instance, [29, 30] and references therein. See also the recent references [31, 32].

The main objective of this paper is the study of contractive fuzzy cyclic multivalued mappings and the convergence properties of sequences constructed via such maps to fuzzy best proximity points and fuzzy fixed points. It is assumed that the subsets defining the cyclic disposal do not necessarily intersect. Some extended results are given for the more general case when the cyclic map can have an image within its domain instead of on its adjacent subset of the cyclic disposal.

1.1 Notation

$$\bar{n} = \{1, 2, \dots, n\};$$

\mathbf{Z}_{0+} , \mathbf{Z}_+ , and \mathbf{Z} are the sets of nonnegative integers, positive integers, and integers, respectively;

\mathbf{R}_{0+} , \mathbf{R}_+ , and \mathbf{R} are the sets of nonnegative real numbers, positive real numbers, and real numbers, respectively.

2 Some preliminaries

Let (X, d) be a metric space, with X nonempty, and let $CB(X)$ be the set of all nonempty closed bounded subsets of X . For $A, B \in CB(X)$, let the Pompeiu-Hausdorff metric (a more appropriate name because of historical reasons than the simpler name ‘Hausdorff metric’ - see the discussion in [33]) H on $CB(X)$ be given by

$$H(A, B) = \max\left(\sup_{a \in A} d(a, B), \sup_{b \in B} d(b, A)\right)$$

for any $A, B \in CB(X)$, where $d(x, A) = \inf_{y \in A} d(x, y)$. A fuzzy set A in X is a function from X to $[0, 1]$ whose grade of membership of x in A is the function-value $A(x)$. The α -level set of A is denoted by $[A]_\alpha$ defined by

$$[A]_\alpha = \{x \in X : A(x) \geq \alpha\} \subseteq X \quad \text{if } \alpha \in (0, 1],$$

$$[A]_0 = \overline{\{x \in X : A(x) > 0\}} \subseteq X,$$

where \bar{B} denotes the closure of B . Let $F(X)$ be the collection of all fuzzy sets in a metric space (X, d) . For $A, B \in F(X)$, $A \subset B$ means $A(x) \leq B(x), \forall x \in X$. Note also that if $\alpha \in [\beta, 1]$ and $\beta \in (0, 1]$, then $[A]_\alpha \subseteq [A]_\beta$. If there exists $\alpha \in [0, 1]$ such that $[A]_\alpha, [B]_\alpha \in CB(X)$, then define

$$p_\alpha(A, B) = \inf_{x \in [A]_\alpha, y \in [B]_\alpha} d(x, y), \quad D_{\alpha\beta}(A, B) = H([A]_\alpha, [B]_\beta),$$

$$D_\alpha(A, B) = D_{\alpha\alpha}(A, B) = H([A]_\alpha, [B]_\alpha)$$

for $\alpha, \beta \in [0, 1]$. Note that $D_{\alpha\beta}(A, B) \neq D_{\beta\alpha}(A, B)$, in general, if $A \neq B$, while $D_{\alpha\beta}(A, B) = D_{\beta\alpha}(B, A)$, and $\max(D_{\alpha\beta}(A, B), D_{\beta\alpha}(A, B)) \geq D_\alpha(A, B)$ if $\alpha \in [\beta, 1]$ and $\beta \in [0, 1]$. If $[A]_\alpha,$

$[B]_\alpha \in CB(X), \forall \alpha \in [0, 1]$, then

$$p(A, B) = \sup_{\alpha \in [0,1]} p_\alpha(A, B), \quad \bar{d}_\infty(A, B) = \sup_{\alpha, \beta \in [0,1]} D_{\alpha\beta}(A, B),$$

$$d_\infty(A, B) = \sup_{\alpha \in [0,1]} D_\alpha(A, B),$$

so that

$$\bar{d}_\infty(A, B) = \sup_{\alpha, \beta \in [0,1]} H([A]_\alpha, [B]_\beta) \geq d_\infty(A, B) = \sup_{\alpha \in [0,1]} H([A]_\alpha, [B]_\alpha).$$

The notation $p(x, A)$ means $p(\{x\}, A)$ and a fuzzy set A in a metric linear space V is said to be an approximate quantity if $[A]_\alpha$ is compact and convex in V for each $\alpha \in [0, 1]$ and $\sup_{x \in V} A(x) = 1$.

The collection of all the approximate quantities in a metric linear space X is denoted by $W(X)$. $T : X \rightarrow F(Y)$ is a fuzzy mapping from an arbitrary set X to $F(Y)$, which is a fuzzy subset in $X \times Y$, and the grade of membership of y in $T(x)$ is $T(x)(y)$.

The notation $f : X|Y \rightarrow Z$ means that the domain of the function f from X to Z is restricted to the subset Y of X .

The next definition characterizes p -cyclic fuzzy mapping in an appropriate way to establish some results of this paper.

Definition 1 Let $p(\geq 2) \in \mathbf{Z}_+$ and let X_i be nonempty subsets of a nonempty abstract set $X, \forall i \in \bar{p}$, and let d be a metric on X . A mapping $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ is said to be a p -cyclic fuzzy mapping from $\bigcup_{i \in \bar{p}} X_i$ to $F(\bigcup_{i \in \bar{p}} X_i)$ if

- (a) $T : \bigcup_{i \in \bar{p}} X_i | X_j \rightarrow F(X_{j+1}); \forall j \in \bar{p}$.
- (b) There is $\alpha(x) \in (0, 1]$ such that the $\alpha(x)$ -level set $[Tx]_{\alpha(x)} \in CB(X_{i+1}); \forall x \in X_i, \forall i \in \bar{p}$.

The above definition is understood under the cyclic constraint $X_{p+1} = X_1$, and in general with $X_{np+i} = X_i$ for any $i \in \bar{p}$ and any $n \in \mathbf{Z}_{0+}$, so that $X_j \equiv X_i$ if $j = i(\text{mod } p)$.

Now, given the sets $X_i, \forall i \in \bar{p}$, the α -level sets in $F(X_i)$ are $[A]_\alpha = \{x \in X_i : A(x) \geq \alpha\}$, where $A(x)$ is the grade of membership of $x \in X_i$ in $A \in F(X_i)$ for any $i \in \bar{p}$. Note that for any given $i \in \bar{p}, z_i \in X_i$ and $\alpha(z_i) \in (0, 1], [Tz_i]_{\alpha(z_i)} = \{x \in X_{i+1} : Tz_i(x) \geq \alpha(z_i)\} \subseteq X_{i+1}$ is the $\alpha(z_i)$ -level set of Tz_i which consists of points in X_{i+1} of guaranteed membership grade not being less than $\alpha(z_i)$. If $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ is a p -cyclic fuzzy mapping, since $[Tz_i]_{\alpha(z_i)}$ is nonempty, there exists $z_{i+1} \in [Tz_i]_{\alpha(z_i)} \subseteq X_{i+1}$ such that $[Tz_{i+1}]_{\alpha(z_{i+1})} = \{x \in X_{i+2} : Tz_{i+1}(x) \geq \alpha(z_{i+1})\} \subseteq X_{i+2}$ is also a nonempty set for some $\alpha(z_{i+1}) \in (0, 1]$ which is contained in the set $[T^2z_i]_{\alpha(z_i)} \equiv [T(Tz_i)]_{\alpha(z_i)}$ for some $\alpha(z_{i+1}) \in (0, 1]$. Then, by recursion, there is a sequence $\{z_{i+j}\} \subseteq \bigcup_{i \in \bar{p}} X_i$ satisfying

$$z_{i+p} \in [Tz_{i+p-1}]_{\alpha(z_{i+p-1})} \subseteq \dots \subseteq [T^{p-1}z_{i+1}]_{\alpha(z_{i+1})} \subseteq [T^p z_i]_{\alpha(z_i)} \subseteq X_i$$

for some set of real values $\alpha(z_j) \in (0, 1]; j = i, i + 1, \dots, i + p - 1; \forall i \in \bar{p}$. The subsequent definition characterizes α -fuzzy best proximity points of some subset X_i of p -cyclic fuzzy mappings.

Definition 2 Let $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ be a $p(\geq 2) \in \mathbf{Z}_+$ -cyclic fuzzy mapping. For any given $i \in \bar{p}$, a point $z_i \in \bar{X}_i$ is said to be an $\alpha(z_i)$ -fuzzy best proximity point of X_i through T for some $\alpha(z_i) \in (0, 1]$ if $d(z_i, [Tz_i]_\alpha) = D_{i\alpha(z_i)} = \inf_{x \in X_i} d(x, [Tx]_\alpha)$.

Remark 3 Note that $D_i = d(X_i, X_{i+1}) \leq D_{i\alpha(x)}$ for any $x \in X_i, \forall i \in \bar{p}$. Note also that if there is $z_i \in X_i$ such that $d(z_i, [Tz_i]_{\alpha(z_i)}) = D_i = d(X_i, X_{i+1})$ for some $i \in \bar{p}$ then there is $z_{i+1} \in [Tz_i]_{\alpha(z_i)} \subseteq X_{i+1}$ such that $d(z_i, z_{i+1}) = D_i$, since then $D_i = D_{i\alpha(z_i)}$. Thus, $z_{i+1} \in \bar{X}_{i+1}$ (then $z_{i+1} \in X_{i+1}$ if X_{i+1} is closed) is a best proximity point of X_{i+1} to X_i . Also, $z_i \in \bar{X}_i$ is a best proximity point of X_i to X_{i+1} and an $\alpha(z_i)$ -best which is also an $\alpha(z_i)$ -fuzzy best proximity point of X_i through T .

The next result relies on the fact that α -fuzzy best proximity points through cyclic self-mappings of adjacent subsets of the cyclic disposal which are not best proximity points can have a mutual distance exceeding the α -fuzzy best proximity distance $D_{i\alpha}$.

The subsequent result is concerned with the existence of a set of coincident best proximity points and α -fuzzy best proximity points each one at each of the subsets of the cyclic disposal of the fuzzy cyclic mapping.

Proposition 4 *The following properties hold:*

(i) *If $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ is a $p(\geq 2)$ -cyclic fuzzy mapping such that X_i and X_{i+1} are closed with the constraints*

$$\sup_{\alpha \in (0,1]} (d(x, [Tz_i]_\alpha) : x \in \bar{X}_{i+2}) < D_i = d(X_i, X_{i+1}) \leq D_{i+1} = d(X_{i+1}, X_{i+2})$$

for some given $i \in \bar{p}$ and $z_i \in X_i$ is an $\alpha(z_i)$ -fuzzy best proximity point of X_i through T for some $\alpha(z_i) \in (0, 1]$, which is also a best proximity point of X_i to X_{i+1} for the given $i \in \bar{p}$. Then

$$d(z_i, z_{i+1}) = d(z_i, [Tz_i]_{\alpha(z_i)}) = d([T^2 z_i]_{\alpha(z_i)}, [Tz_i]_{\alpha(z_i)}) = D_i$$

for some $z_{i+1} \in [Tz_i]_{\alpha(z_i)} \subseteq X_{i+1}$ which is an $\alpha(z_{i+1})$ -fuzzy fixed point of X_{i+1} through T and a best proximity point of X_{i+1} to X_{i+2} .

(ii) *Assume that $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ is a $p(\geq 2)$ -cyclic fuzzy mapping with X_i being closed, $D_i = D, \forall i \in \bar{p}$ and there is some $z_i \in X_i$ which is an $\alpha(z_i)$ -fuzzy best proximity point of X_i through T for some $\alpha(z_i) \in (0, 1]$, which is also a best proximity point of X_i to X_{i+1} for some given $i \in \bar{p}$. Then there exists a sequence of points:*

$$z_{i+j+np} \in [Tz_{i+j+np-1}]_{\alpha(z_{i+j+np-1})} \subseteq [T^2 z_{i+j+np-2}]_{\alpha(z_{i+j+np-2})} \subseteq \dots \subseteq [T^{j+np} z_i]_{\alpha(z_i)} \subseteq X_{i+j},$$

$\forall j \in \bar{p}, \forall n \in \mathbf{Z}_{0+}$, which satisfy the distance constraints:

$$\begin{aligned} d(z_{i+j+np-1}, z_{i+j+np}) &= d(z_{i+j+np-1}, [Tz_{i+j+np-1}]_{\alpha(z_{i+j+np-1})}) \\ &= d([T^{j+np+k+1} z_i]_{\alpha(z_{i+k+1})}, [T^{j+np+k} z_i]_{\alpha(z_{i+k})}) = D; \quad \forall j \in \bar{p}, \forall n, k \in \mathbf{Z}_{0+} \end{aligned}$$

which are best proximity points of X_{i+j} to X_{i+j+1} and $\alpha(z_{i+j+np})$ -fuzzy best proximity points through T for some real values $\alpha(z_{i+j+np}) \in (0, 1], \forall j \in \bar{p}, \forall n, k \in \mathbf{Z}_{0+}$.

Proof It follows that $d(z_i, [Tz_i]_\alpha) = D_i = D_{i\alpha(z_i)}$ since $z_i \in X_i$ is an $\alpha(z_i)$ -fuzzy best proximity point of X_i through T which is also a best proximity point of X_i to X_{i+1} since $[Tz_i]_{\alpha(z_i)} \subseteq X_{i+1}$ is closed.

Note that, for $\alpha(z_{i+1}) \geq \alpha(z_i)$, one gets

$$\begin{aligned}
 [Tz_{i+1}]_{\alpha(z_{i+1})} &= \{z \in X_{i+2} : Tz_{i+1}(z) \geq \alpha(z_{i+1})\} \\
 &\subseteq [T^2z_i]_{\alpha(z_i)} = \{z \in X_{i+2} : T^2z_i(z) \geq \alpha(z_i)\}.
 \end{aligned}$$

Note also that $d([T^2z_i]_{\alpha(z_i)}, [Tz_i]_{\alpha(z_i)}) \geq d(X_{i+1}, X_{i+2}) \geq D_{i+1}$ and then proceed by contradiction by assuming that the above inequality is strict. Therefore, and since $[Tz_i]_{\alpha(z_i)}$ is closed, there is $z_{i+1} \in [Tz_i]_{\alpha(z_i)} \subseteq X_{i+1}$ such that $[Tz_{i+1}]_{\alpha(z_{i+1})} \subseteq [T^2z_i]_{\alpha(z_i)} \subseteq X_{i+2}$ for some $\alpha(z_{i+1}) \in (0, 1]$ so that the following contradiction to the hypothesis $D_i \leq D_{i+1}$ for the given $i \in \bar{p}$ is obtained since $D_i > \sup_{\alpha \in (0,1]} (d(x, [Tz_i]_\alpha) : x \in \bar{X}_{i+2})$:

$$\begin{aligned}
 D_{i\alpha(z_i)} = D_i = d(z_i, z_{i+1}) &= d(z_i, [Tz_i]_{\alpha(z_i)}) \\
 &> d([Tz_i]_{\alpha(z_i)}, [Tz_{i+1}]_{\alpha(z_{i+1})}) \geq d([Tz_i]_{\alpha(z_i)}, [T^2z_i]_{\alpha(z_i)}) \geq D_{i+1},
 \end{aligned}$$

and then $D_i > D_{i+1}$, which is impossible. Thus, $d([T^2z_i]_{\alpha(z_i)}, [Tz_i]_{\alpha(z_i)}) = D_{i+1} \geq D_i = d(z_i, z_{i+1})$. Since $[Tz_{i+1}]_{\alpha(z_{i+1})}$, $[T^2z_i]_{\alpha(z_i)}$, $[Tz_i]_{\alpha(z_i)}$ and X_{i+1} are closed, if $D_i = D_{i+1}$, $z_{i+1} \in [Tz_i]_{\alpha(z_i)} \subseteq X_{i+1}$ is a best proximity point of X_{i+1} to X_{i+2} and an $\alpha(z_{i+1})$ -fuzzy best proximity point of X_{i+1} through T since

$$d(z_{i+1}, [Tz_{i+1}]_{\alpha(z_{i+1})}) = d([T^2z_i]_{\alpha(z_i)}, [Tz_i]_{\alpha(z_i)}) = d(z_{i+1}, z_{i+2}) = D_{i+1}$$

for some $z_{i+2} \in [Tz_{i+1}]_{\alpha(z_{i+1})} \subseteq [T^2z_i]_{\alpha(z_i)} \subseteq X_{i+2}$, since $[Tz_{i+1}]_{\alpha(z_{i+1})}$ is closed. Property (ii) follows by using the recursion $z_{i+j+np} \in [Tz_{i+j+np-1}]_{\alpha(z_{i+j+np-1})} \subseteq \dots \subseteq [T^{i+np}z_i]_{\alpha(z_i)} \subseteq X_{i+j}$, $\forall j \in \bar{p}$, $\forall n \in \mathbf{Z}_{0+}$, and $D_i = D$, $\forall i \in \bar{p}$. □

Note that if for some $i \in \bar{p}$, $z_i \in \bar{X}_i$ is a best proximity point of X_i to X_{i+1} and $(\bigcup_{\alpha \in (0,1]} [Tz_i]_\alpha) \neq \emptyset$, then there exists $z_{i+1} \in [Tz_i]_{\alpha(z_i)} \subset X_{i+1}$ which is an $\alpha = \alpha(z_i) \in (0, 1]$ -fuzzy fixed point of X_{i+1} through T which is also a best proximity point of X_{i+1} to X_i if $D_i = D_{i\alpha(z_i)} = d(X_i, X_{i+1})$ so that

$$D_i = d(z_i, [Tz_i]_{\alpha(z_i)}) = d(z_i, z_{i+1}).$$

If $(\bigcup_{\alpha \in (0,1]} [Tz_i]_\alpha) = \emptyset$ and $[Tz_i]_0 (\neq \emptyset) \subset c l X_{i+1}$ and $D_i = D_{i0}$, then $D_i = d(z_i, [Tz_i]_0) = d(z_i, z_{i+1})$ for some $z_{i+1} \in [Tz_i]_0 \subset \bar{X}_{i+1}$ which is a 0-fuzzy fixed point of X_{i+1} through T and also a best proximity point of X_{i+1} to X_i .

Definition 5 Let $p(\geq 2) \in \mathbf{Z}_+$ and let X_i be nonempty subsets of a nonempty abstract set X , $\forall i \in \bar{p}$, and let d be a metric on X . A composite mapping $T(= gf) : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ is said to be a decomposable p -cyclic fuzzy mapping from $\bigcup_{i \in \bar{p}} X_i$ to $F(\bigcup_{i \in \bar{p}} X_i)$ if:

- (a) $f : \bigcup_{i \in \bar{p}} X_i | X_j \rightarrow X_{j+1}; \forall j \in \bar{p}$,
- (b) $g : \bigcup_{i \in \bar{p}} X_i | X_j \rightarrow F(X_j); \forall j \in \bar{p}$,
- (c) there is $\alpha(x) \in (0, 1]$ such that the $\alpha(x)$ -level set $[Tx]_{\alpha(x)} \in CB(X_{i+1}); \forall x \in X_i, \forall i \in \bar{p}$.

The above definition is an extended definition of Definition 1. Note also that $f(X_i) \subseteq X_{i+1}$, $\forall i \in \bar{p}$, and that, since $T = g \circ f$ with $f : \bigcup_{i \in \bar{p}} X_i | X_j \rightarrow X_{j+1}$, $\forall j \in \bar{p}$ and $g : \bigcup_{i \in \bar{p}} X_i | X_{j+1} \rightarrow F(X_{j+1})$, $\forall j \in \bar{p}$, the cyclic maps $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ are restricted to subsets of the cyclic disposal which are of the form $T : \bigcup_{i \in \bar{p}} X_i | X_j \rightarrow F(X_{j+1})$, $\forall j \in \bar{p}$. On the other hand, notice that the formalism of contractive cyclic self-maps in uniformly convex Banach spaces requires for the distances in-between any pairs of non-adjacent subsets to be identical. Thus, a fixed point, if any, is a confluent point of pairs of best proximity points in-between all the intersecting adjacent subsets of the cyclic disposal. On the other hand, note that the case $f : \bigcup_{i \in \bar{p}} X_i | X_j \rightarrow X_{j+1}$ and $g : \bigcup_{i \in \bar{p}} X_i | X_{j+1} \rightarrow F(X_{j+1})$, $\forall j \in \bar{p}$, is a particular case of the more general above problem statement for the cyclic disposal. Now, given the sets X_i , $\forall i \in \bar{p}$, we can define the α -level sets in $F(X_i)$ by $[A]_\alpha = \{x \in X_i : A(x) \geq \alpha\}$, and $A(x)$ is the grade of membership of $x \in X_i$ in $A \in F(X_i)$ for any $i \in \bar{p}$.

The following assumption establishes that if $T(= gf) : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ is a decomposable p -cyclic fuzzy mapping, then the 1-level set of Tx intersects with fx for any $x \in \bigcup_{i \in \bar{p}} X_i$. Equivalently, there is at least a point $y \in fx$ such that the grade of membership of y in Tx is unity, i.e. $(Tx)y = 1$, for any $x \in \bigcup_{i \in \bar{p}} X_i$. Note that $fx \subseteq X_{i+1}$ and $[Tx]_1 \subseteq X_{i+1}$, $\forall x \in X_i$, $\forall i \in \bar{p}$.

Assumption 6 If $T(= gf) : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ is a decomposable p -cyclic fuzzy mapping, then $fx \subseteq [Tx]_1$, $\forall x \in \bigcup_{i \in \bar{p}} X_i$.

In other words, Assumption 6 says that any image of $x \in X_i$ in X_{i+1} through f belongs to the 1-level set $[Tx]_1 \neq \emptyset$. Note that Assumption 6 implies trivially that $[Tx]_1 \neq \emptyset$, $\forall x \in \bigcup_{i \in \bar{p}} X_i$. Assumption 6 is relevant for identifying best proximity points in-between adjacent subsets through f which are also 1-fuzzy best proximity points through T .

Assertion 7 Assume that $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ is a decomposable p -cyclic fuzzy mapping which satisfies Assumption 6 and that $x \in X_i$ for some given arbitrary $i \in \bar{p}$, such that X_i is closed. Then, if x is a best proximity point of X_i to X_{i+1} through f (in the sense that there exists $y \in fx$ such that $d(x, y) = d(X, X_i)$) then it is an 1-fuzzy best proximity point of X_i through T .

Proof Since $x \in X_i$ is a best proximity point of X_i to X_{i+1} through f and $fx \subseteq [Tx]_1$, $\forall x \in \bigcup_{i \in \bar{p}} X_i$, then there exists $y \in fx$ such that

$$D_{\bar{n}} = d(x, [Tx]_1) \leq d(x, y) = d(x, fx) = d(X, X_i) = D_i \leq D_{\bar{n}} \Rightarrow D_i = D_{\bar{n}}.$$

Then x is an 1-fuzzy best proximity point of X_i through T . □

3 Some results on α -fuzzy best proximity points

The following result holds related to α -fuzzy best proximity points of a p -cyclic fuzzy mapping which is contractive in the sense that it is subject to a contractive condition.

Theorem 8 Let $p(\geq 2) \in \mathbf{Z}_+$ and let X_i be nonempty subsets of a non-empty abstract set X , $\forall i \in \bar{p}$, where (X, d) is a complete metric space. Let $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ be a p -cyclic fuzzy mapping with X_i being closed, $\forall i \in \bar{p}$. Assume that the following contractive condition

holds:

$$\begin{aligned}
 D_{\alpha(x)\alpha(y)}([Tx], [Ty]) &= H([Tx]_{\alpha(x)}, [Ty]_{\alpha(y)}) \\
 &\leq a_1d(x, [Tx]_{\alpha(x)}) + a_2d(y, [Ty]_{\alpha(y)}) + a_3d(x, y) + (1 - a)\Delta; \tag{1}
 \end{aligned}$$

$\forall x \in X_i, \forall y \in X_{i+1}, \forall i \in \bar{p}$, and some $\Delta \in \mathbf{R}_+$ where $a_i \geq 0$ for $i = 1, 2, 3$ and $0 < a = \sum_{i=1}^3 a_i < 1$.

Then the following properties are fulfilled:

(i) Assume that the following constraints hold:

$$\begin{aligned}
 2(a_1 + a_2) + a_3 &< 1, \\
 \Delta &= \frac{(1 - a_2 - a_4)(1 - \rho_0)}{1 - a}, \\
 \rho_0 &= \frac{1}{2} \left[\frac{a_1 + a_3}{1 - a_1 - a_2} + \left(\left(\frac{a_1 + a_3}{1 - a_1 - a_2} \right)^2 + 4 \frac{a_2}{1 - a_1 - a_2} \right)^{1/2} \right] < 1.
 \end{aligned}$$

Then $\limsup_{n \rightarrow \infty} d(x_n, x_{n+1}) \leq \frac{(1-a)\Delta}{(1-a_1-a_2)(1-\rho_0)}$, where $x_{np+j} \in [Tx_{np}]_{\alpha(x_{np})} \subseteq X_{i+j-1}; \forall j \in \bar{4}$ for any given initial points $x_1 \in X_i$ and $x_2 \in X_{i+1}$ for any arbitrary $i \in \bar{p}$.

(ii) For any arbitrarily given $i \in \bar{p}$, a sequence $\{x_n\} \subset \bigcup_{i \in \bar{p}} X_i$ can be built for any given $x = x_1 \in X_i, y = x_2 \in [Tx_1]_{\alpha(x_1)} \subseteq X_{i+1}$ fulfilling $x_{np+j} \in [Tx_{np+j-1}]_{\alpha(x_{np+j-1})} \subseteq X_{i+j-1}; \forall j \in \bar{p}, \forall n \in \mathbf{Z}_{0+}$, which fulfills:

$$\begin{aligned}
 d(x_{np+j+2}, x_{np+j+1}) &\leq \frac{a_1 + a_3}{1 - a_2} d(x_{np+j+1}, x_{np+j}) + \frac{1 - a}{1 - a_2} \Delta, \\
 \forall j \in \overline{p-1} \cup \{0\}, \forall n \in \mathbf{Z}_{0+}, \tag{2}
 \end{aligned}$$

$$\limsup_{n \rightarrow \infty} d(x_{(n+1)p+j+1}, x_{(n+1)p+j}) \leq \Delta, \quad \forall j \in \overline{p-1} \cup \{0\}, \tag{3}$$

$$\limsup_{N \rightarrow \infty} \sum_{n=N_0}^N d(x_{(n+1)p+j+1}, x_{(n+1)p+j}) \leq (M + 1)\Delta < \infty, \quad \forall j \in \overline{p-1} \cup \{0\}, \tag{4}$$

if $|N - N_0| \leq M < \infty$.

(iii) If the constraint (1) holds with $\Delta = D = \min_{i \in \bar{p}} D_i$ then the limit below exists:

$$\lim_{n \rightarrow \infty} d(x_{(n+1)p+j+1}, x_{(n+1)p+j}) = D, \quad \forall j \in \overline{p-1} \cup \{0\}, \tag{5}$$

so that $D = D_i, \forall i \in \bar{p}$, for any sequences constructed as in Property (i). As a result, any sequence $\{x_n\} \subset \bigcup_{i \in \bar{p}} X_i$ fulfilling $x_{np+j} \in [Tx_{np+j-1}]_{\alpha(x_{np+j-1})} \subseteq X_{i+j-1}; \forall j \in \bar{p}, \forall n \in \mathbf{Z}_{0+}$, converges to a limit cycle consisting of a set of p best proximity points x_i^* of the sets $X_i, i \in \bar{p}$, which are also $\alpha(x_{i-1}^*)$ -fuzzy best proximity points of X through $T = g \circ f : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ for some set of values $\alpha(x_{i-1}^*) \in (0, 1]$ and best proximity points of the p -cyclic self-mapping $f : \bigcup_{i \in \bar{p}} X_i \rightarrow \bigcup_{i \in \bar{p}} X_i$.

(iv) If $D = 0$ and the constraint holds with $\Delta = D = \min_{i \in \bar{p}} D_i$, then any sequence $\{x_n\} \subset \bigcup_{i \in \bar{p}} X_i$ fulfilling $x_{np+j} \in [Tx_{np+j-1}]_{\alpha(x_{np+j-1})} \subseteq X_{i+j-1}; \forall j \in \bar{p}, \forall n \in \mathbf{Z}_{0+}$, converges to $x^* \in [Tx^*]_{\alpha(x^*)} \subset \bigcap_{i \in \bar{p}} X_i$ which is a unique $\alpha = \alpha(x^*)$ -fuzzy fixed point of $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$.

Proof Take $x_1 = x \in X_i, x_2 \in X_{i+1}$, for any given arbitrary $i \in \bar{p}$, there exist $x_3 \in [Tx_1]_{\alpha(x_1)}, x_4 \in [Tx_2]_{\alpha(x_2)}$ such that one gets from (1)

$$\begin{aligned} d(x_3, x_4) &\leq H([Tx_1]_{\alpha(x_1)}, [Tx_2]_{\alpha(x_2)}) \\ &\leq a_1 d(x_1, [Tx_1]_{\alpha(x_1)}) + a_2 d(x_2, [Tx_2]_{\alpha(x_2)}) + a_3 d(x_1, x_2) + (1 - a)\Delta \\ &\leq a_1 d(x_1, x_3) + a_2 d(x_2, x_4) + a_3 d(x_1, x_2) + (1 - a)\Delta \\ &\leq a_1 d(x_1, x_2) + a_1 d(x_2, x_4) + a_1 d(x_4, x_3) \\ &\quad + a_2 d(x_2, x_3) + a_2 d(x_3, x_4) + a_3 d(x_1, x_2) + (1 - a)\Delta \\ &= (a_1 + a_3) d(x_1, x_2) + a_2 d(x_2, x_3) + (1 - a)\Delta, \end{aligned}$$

so that

$$d(x_3, x_4) \leq \frac{1}{1 - a_1 - a_2} [(a_1 + a_3) d(x_1, x_2) + a_2 d(x_2, x_3) + (1 - a)\Delta].$$

Then one gets by proceeding recursively for $n \in \mathbb{Z}_+$

$$\begin{aligned} d(x_{np+3}, x_{np+4}) &\leq \frac{1}{1 - a_1 - a_2} [(a_1 + a_3) d(x_{np+1}, x_{np+2}) + a_2 d(x_{np+2}, x_{np+3}) + (1 - a)\Delta]; \\ \forall n \in \mathbb{Z}_{0+}, \end{aligned}$$

where $x_{np+j} \in [Tx_{np}]_{\alpha(x_{np})} \subseteq X_{i+j-1}; \forall j \in \bar{4}$ for the given initial arbitrary $i \in \bar{p}$. Thus,

$$\begin{bmatrix} d(x_{np+2}, x_{np+3}) \\ d(x_{np+3}, x_{np+4}) \end{bmatrix} \leq \begin{bmatrix} 0 & 1 \\ \frac{a_2}{1 - a_1 - a_2} & \frac{a_1 + a_3}{1 - a_1 - a_2} \end{bmatrix} \begin{bmatrix} d(x_{np+1}, x_{np+2}) \\ d(x_{np+2}, x_{np+3}) \end{bmatrix} + \begin{bmatrix} 0 \\ \frac{1 - a}{1 - a_1 - a_2} \Delta \end{bmatrix}; \quad \forall n \in \mathbb{Z}_+.$$

The matrix $A_0 = \begin{bmatrix} 0 & 1 \\ \frac{a_2}{1 - a_1 - a_2} & \frac{a_1 + a_3}{1 - a_1 - a_2} \end{bmatrix}$ is convergent, and then $\|A_0\|^n \rightarrow 0$ as $n \rightarrow \infty$ if and only if its eigenvalues $z_{1,2}$ are inside the complex open unit circle, that is, if and only if

$$z_{1,2} = \frac{1}{2} \left[\frac{a_1 + a_3}{1 - a_1 - a_2} \pm \left(\left(\frac{a_1 + a_3}{1 - a_1 - a_2} \right)^2 + 4 \frac{a_2}{1 - a_1 - a_2} \right)^{1/2} \right] \in (-1, 1),$$

that is, if and only if $2(a_1 + a_2) + a_3 < 1$, while the convergence abscissa of A_0 is

$$\rho_0 = z_2 = \frac{1}{2} \left[\frac{a_1 + a_3}{1 - a_1 - a_2} + \left(\left(\frac{a_1 + a_3}{1 - a_1 - a_2} \right)^2 + 4 \frac{a_2}{1 - a_1 - a_2} \right)^{1/2} \right] < 1.$$

Then $\lim_{n \rightarrow \infty} d(x_{np+3}, x_{np+4}) = \frac{(1-a)\Delta}{(1-a_1-a_2)(1-\rho_0)}$. Since the initial conditions $x_1 \in X_i$ and $x_2 \in X_{i+1}$ of the sequence are arbitrary, it follows that $\limsup_{n \rightarrow \infty} d(x_{np+3}, x_{np+4}) \leq \frac{(1-a)\Delta}{(1-a_1-a_2)(1-\rho_0)}$. On the other hand, since such conditions are taken for any arbitrary $i \in \bar{p}$, $\limsup_{n \rightarrow \infty} d(x_n, x_{n+1}) \leq \frac{(1-a)\Delta}{(1-a_1-a_2)(1-\rho_0)}$. Property (i) has been proved. On the other hand, since for all $x \in X$ there exists $\alpha(x) \in (0, 1]$ such that $[Tx]_{\alpha(x)} \in CB(X)$ and since any $x \in X$ is in some X_i for some $i \in \bar{p}$, we have $[Tx]_{\alpha(x)} \in CB(X_{i+1})$ for some $i \in \bar{p}$ and some $\alpha(x) \in (0, 1]$ for each given $x \in X_i$ and any arbitrary $i \in \bar{p}$. As a result, $[Tx]_{\alpha(x)}$ and $[Ty]_{\alpha(y)}$ are nonempty, closed, and bounded for some existing real values $\alpha(x) \in (0, 1]$ and $\alpha(y) \in (0, 1]; \forall x \in X_i,$

$\forall y \in X_{i+1}, \forall i \in \bar{p}$. Since $[Tx]_{\alpha(x)} \supseteq [Tx]_{\beta(x)}$ if $0 < \alpha(x) \leq \beta(x)$ and $[Tx]_{\alpha(x)}, [Tx]_{\beta(x)} \in CB(X_{i+1})$, $\alpha(x) \in (0, 1]$ can be non-unique with values in $(0, \gamma_i] \subseteq (0, 1]$ for some $\gamma_i \in \mathbf{R}_+$ and $x \in X_i$ for any arbitrary $i \in \bar{p}$. If the image of the correspondence $c : x \rightarrow \alpha(x) (\in (0, 1])$ for some $x \in X$ is such that $[Tx]_{\alpha(x)} \in CB(X)$ is non-unique, then it is possible to choose a mapping $m : x \rightarrow \alpha(x) (\subseteq (0, 1])$ from Zermelo's axiom of choice to fix $\alpha(x) \in (0, 1]$ such that $[Tx]_{\alpha(x)} \in CB(X)$. Construct a sequence $\{x_n\} \subset \bigcup_{i \in \bar{p}} X_i$ as follows. $x_1 = x \in X_i$ for some arbitrary $i \in \bar{p}$ and some existing $x_2 \in [Tx_1]_{\alpha(x_1)}$ since $[Tx_1]_{\alpha(x_1)}$ is nonempty, closed, and bounded for some existing $\alpha(x_1) \in (0, 1]$. Since the contractive condition (1) holds for any $x \in X_i, \forall y \in X_{i+1}, \forall i \in \bar{p}$, then for $x_1 \in X_i$ it follows that there is $x_{02} \in [Tx_1]_{\alpha(x_1)} \subseteq X_{i+1}$ such that $d(x_1, x_{02}) = d(x_1, [Tx_1]_{\alpha(x_1)}) \leq d(x_1, x_2); \forall x_2 \in [Tx_1]_{\alpha(x_1)} \subseteq X_{i+1}$, since $[Tx_1]_{\alpha(x_1)}$ is closed, thus x_{02} is an $\alpha(x_1)$ -fuzzy best proximity points of X_i through T and, since $d(x_2, [Tx_2]_{\alpha(x_2)}) \leq H([Tx_1]_{\alpha(x_1)}, [Tx_2]_{\alpha(x_2)})$ for any $x_2 \in [Tx_1]_{\alpha(x_1)} \subseteq X_{i+1}$, one gets

$$\begin{aligned}
 & d(x_2, [Tx_2]_{\alpha(x_2)}) \\
 & \leq a_1 d(x_1, [Tx_1]_{\alpha(x_1)}) + a_2 d(x_2, [Tx_2]_{\alpha(x_2)}) + a_3 d(x_1, x_2) + (1 - a) \Delta \\
 & \leq a_1 d(x_1, x_{02}) + a_2 d(x_2, [Tx_2]_{\alpha(x_2)}) + a_3 d(x_1, x_2) + (1 - a) \Delta \\
 & \leq a_1 d(x_1, x_2) + a_2 d(x_2, [Tx_2]_{\alpha(x_2)}) + a_3 d(x_1, x_2) + (1 - a) \Delta \\
 & \leq a_1 d(x_1, x_2) + a_2 d(x_2, [Tx_2]_{\alpha(x_2)}) + a_3 d(x_1, x_2) + (1 - a) \Delta.
 \end{aligned} \tag{6}$$

Then

$$(1 - a_2) d(x_2, [Tx_2]_{\alpha(x_2)}) \leq (a_1 + a_3) d(x_1, x_2) + (1 - a) \Delta$$

and, since $[Tx_2]_{\alpha(x_2)}$ is nonempty and closed, there is some $x_3 \in [Tx_2]_{\alpha(x_2)} \subseteq X_{i+1}$ such that

$$d(x_2, x_3) \leq d(x_2, [Tx_2]_{\alpha(x_2)}) \leq \frac{a_1 + a_3}{1 - a_2} d(x_1, x_2) + \frac{1 - a}{1 - a_2} \Delta; \tag{7}$$

and since $[Tx_2]_{\alpha(x_2)}$ is nonempty and closed, at least one x_3 may be chosen for which the first inequality of (7) becomes an equality and x_2 is an $\alpha(x_2)$ -fuzzy best proximity points of X_{i+1} through T . Proceeding recursively, one sees for the arbitrary given $i \in \bar{p}, \forall j \in \bar{p}, \forall n \in \mathbf{Z}_{0+}$, that a sequence in $\bigcup_{i \in \bar{p}} X_i$ can be built fulfilling (6) for any arbitrary $i \in \bar{p}$ such that $x_1 = x \in X_i$ is chosen arbitrarily, $x_2 \in [Tx_1]_{\alpha(x_1)} \subseteq X_{i+1}, \dots, x_{np+j} \in [Tx_{np+j-1}]_{\alpha(x_{np+j-1})} \subseteq X_{i+j-1}, x_{np+j+1} \in [Tx_{np+j}]_{\alpha(x_{np+j})} \subseteq X_{i+j}, x_{np+j+2} \in [Tx_{np+j+1}]_{\alpha(x_{np+j+1})} \subseteq X_{i+j+1}, \dots; \forall j \in \bar{p}, \forall n \in \mathbf{Z}_{0+}$, and, furthermore, x_n of $\alpha(x_n)$ -fuzzy best proximity points of X through T for $n \in \mathbf{Z}_+$. Since, from the given hypotheses, $0 \leq K = \frac{a_1 + a_3}{1 - a_2} < 1$ and $0 < 1 - K = \frac{1 - a}{1 - a_2} < 1$, so that $(1 - K)D = \frac{1 - a}{1 - a_2} \Delta$ if $\Delta = D$, one gets from (7) for $j = p$

$$\begin{aligned}
 & d(x_{(n+1)p+j+2}, x_{(n+1)p+j+1}) \leq K d(x_{(n+1)p+j+1}, x_{(n+1)p+j}) + (1 - K) \Delta \\
 & \leq K^{np+j} d(x_2, x_1) + (1 - K^{np+j}) \Delta, \\
 & \forall n \in \mathbf{Z}_{0+}, \forall j \in \overline{p - 1} \cup \{0\}.
 \end{aligned} \tag{8}$$

Thus, one sees from (8) that (3) holds and, furthermore,

$$\sum_{n=N_0}^N d(x_{(n+1)p+j+2}, x_{(n+1)p+j+1}) \leq (N - N_0 + 1)\Delta - K^{(j+N_0)p} \frac{1 - K^{(N-N_0+1)p}}{1 - K^p} (\Delta - d(x_2, x_1)); \tag{9}$$

$\forall j \in \overline{p-1} \cup \{0\}$, which leads to (4) if $|N - N_0| \leq M < \infty$. Property (ii) has been proved.

On the other hand, if (1) holds with $\Delta = D = \min_{i \in \bar{p}} D_i$, then one gets from (3)

$$D \leq D_{j+i} \leq \limsup_{n \rightarrow \infty} d(x_{(n+1)p+j+1}, x_{(n+1)p+j}) \leq D, \quad \forall j \in \overline{p-1} \cup \{0\} \tag{10}$$

(since $D_i < D = \min_{i \in \bar{p}} D_i$ is impossible for any $i \in \bar{p}$) so that the limit $\lim_{n \rightarrow \infty} d(x_{(n+1)p+j+1}, x_{(n+1)p+j}) = D, \forall j \in \overline{p-1} \cup \{0\}$ exists so that $D = D_i, \forall i \in \bar{p}$, and the sequence converges to a limit cycle consisting of a set of p best proximity points x_i^* of the sets $X_i, i \in \bar{p}$, which are also $\alpha(x_{i-1}^*)$ -fuzzy best proximity points of X through T for some set of values $\alpha(x_{i-1}^*) \in (0, 1]$. Since $d(X_i, X_{i+1}) = D, \forall i \in \bar{p}$, the elements of the limiting set $\{x_i^* : i \in \bar{p}\}$ are also best proximity points of the corresponding sets $X_i, \forall i \in \bar{p}$. On the other hand, if $D = 0$, and since $\lim_{n \rightarrow \infty} d(x_{(n+1)p+j+1}, x_{(n+1)p+j}) = D, \forall j \in \overline{p-1} \cup \{0\}$, from Property (ii), we have $x_i^* = x^* \in [Tx^*]_{\alpha(x^*)}, \forall i \in \bar{p}$, and $\emptyset \neq \bigcap_{i \in \bar{p}} [Tx^*]_{\alpha(x^*)} \subseteq \bigcap_{i \in \bar{p}} X_i$, so that x^* is an $\alpha(x^*)$ -fuzzy fixed point of $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ for some $\alpha \in (0, 1]$. We also know the property $[Tx]_{\beta} \geq [Tx]_{\alpha}$ for all $\beta (\leq \alpha), \alpha (\leq \alpha^*) \in (0, 1]$ and some $\alpha^* \in (0, 1]$. Therefore, there is a real constant:

$$\alpha^* = \alpha^*(x^*) = \max \left(\alpha \in (0, 1] : \left(\bigcap_{i \in \bar{p}} [Tx^*]_{\beta \leq \alpha} \right) \right),$$

so that $x^* \in [Tx^*]_{\alpha^*}$ is an α^* -fuzzy fixed point of $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ which is the unique limit point of the built sequence.

Now, assume that there are two distinct fuzzy fixed points $x^* \in [Tx]_{\alpha^*}$ and $y^* \in [Ty]_{\beta^*}$. Then one gets from (1) with $\Delta = D = 0$, if $x^* \in [Tx]_{\alpha(x^*)}$ and $y_1 = y^* (\neq x^*) \in \bigcup_{i \in \bar{p}} X_i$, and since the level sets are nonempty and closed, and one gets from (1), $d(x^*, [Tx]_{\alpha(x^*)}) = d(y^*, [Ty]_{\alpha(y^*)}) = \Delta = D = 0$, so that

$$d(x_2, y_2) = d(y_2, [Tx_1]_{\alpha^*}) = D([Tx_1]_{\alpha^*}, [Ty_1]_{\alpha(y_1)}) \leq a_3 d(x^*, y^*) < d(x^*, y^*)$$

for some $x_2 = x_2(y_2) \in [Tx_1]_{\alpha(x_1)}$ and all $y_2 \in [Ty_1]_{\alpha(y_1)}$ with $\alpha(x_1) = \alpha(x^*) = \alpha^*$ and $\alpha(y_1) = \alpha(y^*) = \beta^*$. Again, one gets from (1) for some $y_2 \in [Ty^*]_{\alpha(y^*)}$, since $y_1 = y^*, [Ty_1]_{\alpha(y_1)} \equiv [Ty^*]_{\alpha(y^*)}$ is closed and $x^* \in [Tx]_{\alpha(x^*)}$,

$$\begin{aligned} d(x^*, y_2) &= d(x^*, [Ty_1]_{\alpha(y_1)}) \\ &\leq \max \left(\sup_{y \in [Ty_1]_{\alpha(y_1)}} d(y, [Tx^*]_{\alpha(x^*)}), \sup_{x \in [Tx^*]_{\alpha(x^*)}} d(x, [Ty_1]_{\alpha(y_1)}) \right) \\ &= H([Tx^*]_{\alpha(x^*)}, [Ty^*]_{\alpha(y^*)}) \\ &\leq a_1 d(x^*, [Tx^*]_{\alpha(x^*)}) + a_2 d(y^*, [Ty^*]_{\alpha(y^*)}) + a_3 d(x^*, y^*) \end{aligned}$$

$$\begin{aligned}
 &= a_2d(y_1, [Ty_1]_{\alpha(y_1)}) + a_3d(x^*, y_1) \\
 &= a_3d(x^*, y_1) < d(x^*, y_1^*)
 \end{aligned}
 \tag{11}$$

and a sequence $\{y_n\}$ can be built with initial value $y_1 = y^*$ which satisfies

$$\begin{aligned}
 d(x^*, y_{n+1}) &= d(x^*, [Ty_n]_{\alpha(y_n)}) \\
 &\leq \max\left(\sup_{y \in [Ty_n]_{\alpha(y_n)}} d(y, [Tx^*]_{\alpha(x^*)}), \sup_{x \in [Tx^*]_{\alpha(x^*)}} d(x, [Ty_n]_{\alpha(y_n)})\right) \\
 &\leq a_2d(y_n, [Ty_n]_{\alpha(y_n)}) + a_3d(x^*, y_n) \\
 &\leq a_2d(y_n, y_{n+1}) + a_3d(x^*, y_n), \quad \forall n \in \mathbf{Z}_+.
 \end{aligned}
 \tag{12}$$

Then one gets from (12)

$$\begin{aligned}
 d(x^*, y_{n+1}) &\leq a_2d(y_n, y_{n+1}) + a_3d(x^*, y_n) \leq a_2(d(y_n, x^*) + d(x^*, y_{n+1})) + a_3d(x^*, y_n) \\
 &\leq (a_2 + a_3)d(y_n, x^*) + a_2d(x^*, y_{n+1}), \quad \forall n \in \mathbf{Z}_{0+}
 \end{aligned}
 \tag{13}$$

$$\Rightarrow d(x^*, y_{n+1}) \leq (1 - a_2)^{-1}(a_2 + a_3)d(y_n, x^*), \quad \forall n \in \mathbf{Z}_{0+}
 \tag{14}$$

since $a_2 < 1$. If $a_1 \geq a_2$ then $(1 - a_2)^{-1}(a_2 + a_3) < 1$, equivalently, $2a_2 + a_3 < 1$, since $a = a_1 + a_2 + a_3 < 1$ implies that $2a_2 + a_3 < 1$ if $a_1 \geq a_2$. On the other hand, one also sees instead of (12) and (14) that a sequence $\{x_n\}$ can be built with initial value $x_1 = x^*$ which satisfies

$$\begin{aligned}
 d(y^*, x_{n+1}) &= d(y^*, [Tx_n]_{\alpha(x_n)}) = d(x^*, [Ty_n]_{\alpha(y_n)}) \\
 &\leq a_1d(x_n, x_{n+1}) + a_3d(y^*, x_n), \quad \forall n \in \mathbf{Z}_+,
 \end{aligned}
 \tag{15}$$

$$d(x^*, x_{n+1}) \leq (1 - a_1)^{-1}(a_1 + a_3)d(x_n, x^*), \quad \forall n \in \mathbf{Z}_+,
 \tag{16}$$

since $a_1 < 1$. If $a_1 \leq a_2$ then $(1 - a_1)^{-1}(a_1 + a_3) < 1$, equivalently, $2a_1 + a_3 < 1$, since $a = a_1 + a_2 + a_3 < 1$. Since $a < 1$, it follows that $\rho = \min(\frac{a_2+a_3}{1-a_2}, \frac{a_1+a_3}{1-a_1}) < 1$. Thus, it follows from (14) that $d(x^*, y_n) \rightarrow 0$ as $n \rightarrow \infty$ if $2a_2 + a_3 < 1$. Then a sequence with initial condition y^* converges to x^* . Also, one gets from (16) $d(y^*, x_n) \rightarrow 0$ as $n \rightarrow \infty$ if $2a_1 + a_3 < 1$. Then a sequence with initial condition x^* converges to y^* . Then x^* and y^* cannot be distinct α -fuzzy fixed points. Properties (iii)-(iv) have been proved. \square

Remark 9 The uniqueness of the limiting fixed point for some $\alpha^* \in (0, 1]$ of each built sequence proved in Theorem 8(iv), which is also an α^* -fuzzy fixed point of T , follows from the existence of the maximum α^* such that $x^* \in [Tx^*]_{\alpha^*}$. On the other hand, the conclusion of Theorem 8(iv) that the distances in-between adjacent subsets are identical is not very surprising, since it has been found to be a general property for nonexpansive mappings for p -cyclic nonexpansive self-mappings in metric spaces (Lemma 3.3, [5]).

Remark 10 Feasible values of Δ in the contractive condition (1) might be, for instance,

$$\begin{aligned}
 \Delta &= \bar{d}_{\infty}(x_n : n \in \mathbf{Z}_+) = \sup_{j \in \mathbf{Z}_+} d_{\infty}([Tx_j]_{\alpha(x_j)}, [Tx_{j+1}]_{\alpha(x_{j+1})}) \\
 &\leq \sup_{j \in \mathbf{Z}_+} d_{\infty}([Tx_j]_{\alpha(x_j)}, [Tx_{j+1}]_{\alpha(x_{j+1})}),
 \end{aligned}$$

or Δ replaced with the j th iteration-dependent values $\Delta_j = d_\infty([Tx_j]_{\alpha(x_j)}, [Tx_{j+1}]_{\alpha(x_{j+1})})$. From the last expression one also concludes that $\limsup_{n \rightarrow \infty} d(x_{(n+1)p+j+2}, x_{(n+1)p+j+1}) \leq \Delta$, $\forall j \in \overline{p-1} \cup \{0\}$. Both values depend only on the sequences being constructed rather than on the metrics of the sets $X_i, i \in \bar{p}$.

Corollary 11 *Assume that the contractive condition (1) of Theorem 8 holds with $\Delta = \Delta(x, [Tx]_{\alpha(x)}) \leq D_{\alpha(x)\alpha(y)}([Tx]_{\alpha(x)}, [Ty]_{\alpha(y)})$ for all given $x \in X_i$ and $y \in [Tx]_{\alpha(x)} \subseteq X_{i+1}$ for any given arbitrary $i \in \bar{p}$. Then there is a (non-necessarily unique) sequence $\{x_n\}$ of $\alpha(x_n)$ -fuzzy best proximity points of X through T with first element $x \in X_i$, being subject to free choice if $\text{card} X_i \geq 2$, for any given $i \in \bar{p}$ such that the sequence of distances $\{d(x_n, x_{n+1})\}$ is non-increasing. A possible choice is a constant sequence.*

Proof The contractive condition (1) now becomes

$$D_{\alpha(x)\alpha(y)}([Tx]_{\alpha(x)}, [Ty]_{\alpha(y)}) \leq a^{-1}(a_1 d(x, [Tx]_{\alpha(x)}) + a_2 d(y, [Ty]_{\alpha(y)}) + a_3 d(x, y)); \tag{17}$$

$\forall x \in X_i, \forall y \in X_{i+1}, \forall i \in \bar{p}$, and, instead of (7), one sees for any $x_1 \in X_i$ for any $i \in \bar{p}$, that there exist (non-unique, in general, see the proof of Theorem 8) $\alpha(x_1) \in (0, 1], x_2 \in [Tx_1]_{\alpha(x_1)} \subseteq X_{i+1}, \alpha(x_2) \in (0, 1]$, and $x_3 \in [Tx_2]_{\alpha(x_2)} \subseteq X_{i+2}$, since $[Tx_1]_{\alpha(x_1)}$ and $[Tx_2]_{\alpha(x_2)}$ are nonempty, closed, and bounded:

$$d(x_2, x_3) \leq d(x_2, [Tx_2]_{\alpha(x_2)}) \leq \frac{a^{-1}(a_1 + a_3)}{a - a^{-1}a_2} d(x_1, x_2) = d(x_1, x_2), \tag{18}$$

so that

$$d(x_{n+2}, x_{n+1}) \leq d(x_{n+1}, x_n) \leq \dots \leq d(x_2, x_1), \quad \forall n \in \mathbf{Z}_{0+}, \tag{19}$$

$$\limsup_{n \rightarrow \infty} d(x_{n+1}, x_n) \leq d(x_1, x_2) \leq d(x_1, [Tx_1]_{\alpha(x_1)}), \tag{20}$$

$$\begin{aligned} d(x_1, x_2) &= d(x_1, [Tx_1]_{\alpha(x_1)}) = D_{i\alpha(x_1)} = \inf_{x_1 \in X_i} d(x_1, [Tx_1]_{\alpha(x_1)}) \\ &= D_{\alpha(x_1)\alpha(x_2)}([Tx_1]_{\alpha(x_1)}, [Tx_2]_{\alpha(x_2)}), \\ &\dots \\ d(x_n, x_{n+1}) &= d(x_n, [Tx_n]_{\alpha(x_n)}) = D_{i+n-1, \alpha(x_n)} = \inf_{x_n \in X_{i+n-1}} d(x_n, [Tx_n]_{\alpha(x_n)}) \quad \text{for } n \in \bar{p}, \\ &\dots \\ d(x_{(n+1)p+j+2}, x_{(n+1)p+j+1}) &= d(x_{(n+1)p+j+1}, [Tx_{(n+1)p+j+1}]_{\alpha(x_{(n+1)p+j+1})}), \tag{21} \\ &\dots \end{aligned}$$

with $x_{np+j+1} \in [Tx_{np+j}]_{\alpha(x_{np+j})} \subseteq X_{i+j}, \forall j \in \overline{p-1} \cup \{0\}, \forall n \in \mathbf{Z}_{0+}$, for the chosen arbitrary $i \in \bar{p}$ such that $\{x_n\}$ is a sequence of $\alpha(x_n)$ -fuzzy best proximity points of X through T with first element $x \in X_i$, subject to free choice if $\text{card} X_i \geq 2$, for any given $i \in \bar{p}$, and the sequence of distances $\{d(x_n, x_{n+1})\}$ is non-increasing. □

Corollary 12 *A constant sequence exists which satisfies Corollary 11.*

Proof It follows since elements of the sequence $\{x_n\}$ can be chosen so that the first inequalities of (12) and (13) are equalities for $n \in \mathbf{Z}_+$ so that $d(x_n, x_{n+1}) = d(x_2, x_1), \forall n \in \mathbf{Z}_+$. \square

Example 13 Let $X = X_1 \cup X_2$ and $X_1 = \{1, 2, 3\}, \{1\}, \{2\}, \{3\}$ and $X_2 = \{0.6, 0.7, 0.8\}, \{0.6\}, \{0.7\}, \{0.8\}$ be crisp sets and let $T : X_1 \cup X_2 \rightarrow F(X_1 \cup X_2)$ be a 2-cyclic fuzzy mapping defined as follows:

$$\begin{aligned}
 T(1)(t) &= \begin{cases} 3/4 & \text{if } t = 0.8, \\ 1/2 & \text{if } t = 0.7, \\ 0 & \text{if } t = 0.6; \end{cases} & T(2)(t) &= \begin{cases} 0 & \text{if } t = 0.8, \\ 1/3 & \text{if } t = 0.7, \\ 3/4 & \text{if } t = 0.6; \end{cases} \\
 T(0.8)(t) &= \begin{cases} 3/4 & \text{if } t = 1, \\ 1/2 & \text{if } t = 2, \\ 0 & \text{if } t = 3; \end{cases} & T(0.6)(t) = T(0.7)(t) &= \begin{cases} 0 & \text{if } t = 1, \\ 1/3 & \text{if } t = 2, \\ 3/4 & \text{if } t = 3. \end{cases}
 \end{aligned}$$

The α -level sets are

$$\begin{aligned}
 [T1]_{1/2} &= [T3]_{1/2} = \{0.7, 0.8\}, \\
 [T1]_{3/4} &= [T3]_{3/4} = \{0.8\}, \\
 [T0.7]_{\alpha} &= [T0.6]_{\alpha} = \{3\}; \quad \alpha \in (1/2, 3/4), \\
 [T2]_{\alpha} &= \{0.6\}; \quad \alpha \in (1/2, 3/4), \\
 [T0.8]_{1/2} &= \{1, 2\}, \\
 [T0.8]_{3/4} &= \{1\}.
 \end{aligned}$$

Let $d : X \times X \rightarrow \mathbf{R}_{0+}$ be the Euclidean norm, then $D = d(X_1, X_2) = 0.2$. Point to image set distances and Pompeiu- Hausdorff distances are the following:

$$\begin{aligned}
 d(x, [Tx]_{\alpha}) &= 0.2; \quad x \in \{1, 3\}, \alpha \in (1/2, 3/4), \\
 d(2, [T2]_{\alpha}) &= 1.4; \quad \alpha \in (1/2, 3/4), \\
 d(0.6, [T0.6]_{\alpha}) &= d(0.7, [T0.7]_{\alpha}) = 2.4; \quad \alpha \in (1/2, 3/4), \\
 d(0.8, [T0.8]_{\alpha}) &= 0.2; \quad \alpha \in (1/2, 3/4),
 \end{aligned}$$

and

$$\begin{aligned}
 H([T2]_{\alpha}, [Ty]_{1/2}) &= H([Tx]_{1/2}, [Ty]_{\alpha}) = 2.3; \quad x = \{1, 3\}, y \in \{0.6, 0.7\}, \alpha \in \{1/2, 3/4\}, \\
 H([T2]_{\alpha}, [Ty]_{3/4}) &= H([Tx]_{3/4}, [Ty]_{\alpha}) = 2.2; \quad x = \{1, 3\}, y \in \{0.6, 0.7\}, \alpha \in \{1/2, 3/4\}, \\
 H([T2]_{\alpha}, [T0.8]_{3/4}) &= 0.4; \quad \alpha \in \{1/2, 3/4\}, \\
 H([T2]_{\alpha}, [T0.8]_{1/2}) &= 1.4; \quad \alpha \in \{1/2, 3/4\}, \\
 H([T0.8]_{3/4}, [Tx]_{1/2}) &= 0.3; \quad x = \{1, 3\}, \\
 H([T0.8]_{3/4}, [Tx]_{3/4}) &= 0.2; \quad x = \{1, 3\}, \\
 H([T0.8]_{1/2}, [Tx]_{1/2}) &= 1.3; \quad x = \{1, 3\},
 \end{aligned}$$

$$H([T0.8]_{1/2}, [Tx]_{3/4}) = 1.2; \quad x = \{1, 3\}.$$

The contractive constraint (1) and Theorem 8 can be applied with $a_2 = 0.8, a_1 + a_3 < 1 - a_2$. Some sequences which converge to α -fuzzy best proximity points of X_1 and X_2 through T , which are also best proximity points in X_1 of X_2 and conversely, are

$$\begin{aligned} & \{1, 0.8 \in [T1]_{3/4}, 1 \in [T0.8]_{3/4}, \dots\}, \\ & \{1, 0.7 \in [T1]_{1/2}, 3 \in [T0.7]_{3/4}, 0.8 \in [T3]_{3/4}, 1 \in [T0.8]_{1/2}, \\ & \quad 0.8 \in [T1]_{3/4}, 1 \in [T0.8]_{3/4}, \dots\}. \end{aligned}$$

4 Further results on α -fuzzy best proximity points under a more general contractive condition

We now establish the following result related to a contractive condition which is more general than (1).

Theorem 14 *Let $p(\geq 2) \in \mathbf{Z}_+$ and let X_i be nonempty subsets of a nonempty abstract set X , $\forall i \in \bar{p}$, where (X, d) is a complete metric space. Let $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ be a p -cyclic fuzzy mapping with X_i being closed, $\forall i \in \bar{p}$. Assume that the following contractive condition holds:*

$$\begin{aligned} H([Tx]_{\alpha(x)}, [Ty]_{\alpha(y)}) & \leq a_1 d(x, [Tx]_{\alpha(x)}) + a_2 d(y, [Ty]_{\alpha(y)}) + a_3 d(x, y) \\ & \quad + a_4 d(x, [Ty]_{\alpha(y)}) + a_5 d(y, [Tx]_{\alpha(x)}) + (1 - a)\Delta; \end{aligned} \tag{22}$$

$\forall x \in X_i, \forall y \in X_{i+1}, \forall i \in \bar{p}$, and some $\Delta \in \mathbf{R}_+$ where $a_i \geq 0$ for $i = 1, 2, 3$ and $0 < a = \sum_{i=1}^5 a_i < 1$. Then the following properties hold:

(i) *For any arbitrarily given $i \in \bar{p}, \forall j \in \bar{p}, \forall n \in \mathbf{Z}_{0+}$, and $x = x_1 \in X_i$, a sequence $\{x_n\} \subset \bigcup_{i \in \bar{p}} X_i$ can be built fulfilling $\{x_n\} \subseteq \bigcup_{i \in \bar{p}} X_i$ for any given initial points $x_1 = x \in X_i$ for any given $i \in \bar{p}, x_2 \in [Tx_1]_{\alpha(x_1)} \subseteq X_{i+1}, x_3 = y \in X_{i+1}$, and $x_4 \in [Tx_3]_{\alpha(x_3)} \subseteq X_{i+2}, \forall n \in \mathbf{Z}_+$, such that*

$$\limsup_{n \rightarrow \infty} \|d(x_n, x_{n+1})\|_2 \leq \frac{(1 - a)\Delta}{(1 - a_2 - a_4)(1 - \rho)},$$

provided that $\theta = a_2 + a_4 + 2(a_1 + a_3) + a_5 < 1$, where

$$\rho = \frac{1}{2} \left(\frac{a_1 + a_3 + a_5}{1 - a_2 - a_4} + \left(\left(\frac{a_1 + a_3 + a_5}{1 - a_2 - a_4} \right)^2 + 4 \frac{a_1 + a_3}{1 - a_2 - a_4} \right)^{1/2} \right).$$

(ii) *If $\Delta = D = D_i; \forall i \in \bar{p}, a_1 = a_3 = 0, \theta = a_2 + a_4 + a_5 < 1$, then a sequence $\{x_n\} \subset \bigcup_{i \in \bar{p}} X_i$ can be built with initial points $x_1 = x \in X_i$ for any arbitrary given $i \in \bar{p}, x_2 \in [Tx_1]_{\alpha(x_1)} \subseteq X_{i+1}, x_3 = y \in X_{i+1}$, and $x_4 \in [Tx_3]_{\alpha(x_3)} \subseteq X_{i+2}$ which satisfies*

$$\begin{aligned} x_{np+1} \in [Tx_{np}]_{\alpha(x_{np})} \subseteq X_i, \quad x_{np+2} \in [Tx_{np+1}]_{\alpha(x_{np+1})} \subseteq X_{i+1}, \\ x_{np+3} \in [Tx_{np+2}]_{\alpha(x_{np+2})} \subseteq X_{i+1}, \quad x_{np+4} \in [Tx_{np+2}]_{\alpha(x_{np+2})} \subseteq X_{i+2}, \end{aligned}$$

and

$$\begin{aligned}
 d(x_{np+1}, x_{np+2}) &\rightarrow D, & d(x_{np+2}, x_{np+3}) &\rightarrow 0, & d(x_{np+3}, x_{np+4}) &\rightarrow D, \\
 d(x_{np+4}, x_{np+5}) &\rightarrow 0, & \dots & & &
 \end{aligned}$$

as $n \rightarrow \infty$.

Thus, the sequence contains a convergent subsequence to a limit cycle consisting of a set of p best proximity points x_i^* of the sets X_i , for $i \in \bar{p}$, which are also $\alpha(x_{i-1}^*)$ -fuzzy best proximity points of X through T for some set of values $\alpha(x_{i-1}^*) \in (0, 1]$. If $D = 0$ then the above convergent subsequence converges to a unique $\alpha = \alpha(x^*)$ -fuzzy fixed point of $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$.

Proof Since $[Tx]_\alpha$ and $[Ty]_\beta$ are nonempty and closed for some $\alpha \in (0, \gamma_a] \subseteq (0, 1]$ and $\beta \in (0, \gamma_b] \subseteq (0, 1]$, we can choose any points $x \in X_i$ and $y \in [Tx]_{\alpha(x)} \subseteq X_{i+1}$ (then $d(y, [Tx]_{\alpha(x)}) = 0$ and $d(x, y) \geq d(x, [Tx]_{\alpha(x)})$). Thus, (22) becomes

$$\begin{aligned}
 d(y, [Ty]_{\alpha(y)}) &\leq H([Tx]_{\alpha(x)}, [Ty]_{\alpha(y)}) \\
 &\leq a_1 d(x, [Tx]_{\alpha(x)}) + a_2 d(y, [Ty]_{\alpha(y)}) + a_3 d(x, y) \\
 &\quad + a_4 d(x, [Ty]_{\alpha(y)}) + (1 - a) \Delta
 \end{aligned} \tag{23}$$

\Rightarrow

$$\begin{aligned}
 d(y, [Ty]_{\alpha(y)}) &\leq (1 - a_2)^{-1} [a_1 d(x, [Tx]_{\alpha(x)}) + a_3 d(x, y) + a_4 d(x, [Ty]_{\alpha(y)}) + (1 - a) \Delta] \\
 &\leq (1 - a_2)^{-1} [(a_1 + a_3) d(x, y) + a_4 d(x, [Ty]_{\alpha(y)}) + (1 - a) \Delta].
 \end{aligned} \tag{24}$$

Further assume that $d(y, [Ty]_{\alpha(y)}) \geq d(x, [Ty]_{\alpha(y)})$ for the chosen x, y . Then one gets from (24) the following cases:

Case (a) If $y \in [Tx]_{\alpha(x)}$ and $d(y, [Ty]_{\alpha(y)}) \geq d(x, [Ty]_{\alpha(y)})$ then

$$d(x, [Ty]_{\alpha(y)}) \leq \frac{1}{1 - a_2 - a_4} [(a_1 + a_3) d(x, y) + (1 - a) \Delta]. \tag{25}$$

Case (b) Assume that $y \in [Tx]_{\alpha(x)}$ and $d(y, [Ty]_{\alpha(y)}) \leq d(x, [Ty]_{\alpha(y)})$ so that, by using those relations in the right-hand side of (23), one gets

$$\begin{aligned}
 d(y, [Ty]_{\alpha(y)}) &\leq H([Tx]_{\alpha(x)}, [Ty]_{\alpha(y)}) \\
 &\leq a_1 d(x, [Tx]_{\alpha(x)}) + (a_2 + a_4) d(y, [Ty]_{\alpha(y)}) + a_3 d(x, y) + (1 - a) \Delta;
 \end{aligned} \tag{26}$$

then

$$\begin{aligned}
 d(y, [Ty]_{\alpha(y)}) &\leq (1 - a_2 - a_4)^{-1} [a_1 d(x, [Tx]_{\alpha(x)}) + a_3 d(x, y) + (1 - a) \Delta] \\
 &\leq \frac{1}{1 - a_2 - a_4} [(a_1 + a_3) d(x, y) + (1 - a) \Delta].
 \end{aligned} \tag{27}$$

Joint Cases (a)-(b) The combination of (25) and (27) yields, if $y \in [Tx]_{\alpha(x)}$,

$$\max(d(x, [Ty]_{\alpha(y)}), d(y, [Ty]_{\alpha(y)})) \leq \frac{1}{1 - a_2 - a_4} [(a_1 + a_3) d(x, y) + (1 - a) \Delta]. \tag{28}$$

Case (c) If $y \notin [Tx]_{\alpha(x)}$ then $d(y, [Tx]_{\alpha(x)}) \neq 0$, so that (28) becomes via (25) and (27) for this case that

$$\begin{aligned} & \max(d(x, [Ty]_{\alpha(y)}), d(y, [Ty]_{\alpha(y)})) \\ & \leq \frac{1}{1 - a_2 - a_4} [(a_1 + a_3)d(x, y) + a_5d(y, [Tx]_{\alpha(x)}) + (1 - a)\Delta], \end{aligned} \tag{29}$$

which is more general than (28). Now, construct the sequence $\{x_n\} \subseteq \bigcup_{i \in \bar{p}} X_i$ with $x_1 = x \in X_i$ for some given $i \in \bar{p}$, $x_2 \in [Tx_1]_{\alpha(x_1)} \in X_{i+1}$, $x_3 = y \in X_{i+1}$, and $x_4 \in [Tx_3]_{\alpha(x_3)} \in X_{i+2}$ such that $d(x_2, x_4) = d(x_2, [Tx_3]_{\alpha(x_3)})$, which exists since $[Tx_2]_{\alpha(x_2)}$ is nonempty and closed. Thus, one gets after using the triangle inequality $d(x_1, x_3) \leq d(x_1, x_2) + d(x_2, x_3)$ in the right-hand side of (29)

$$\begin{aligned} d(x_3, x_4) & \leq \max(d(x_1, x_4), d(x_3, x_4)) \\ & \leq \frac{1}{1 - a_2 - a_4} [(a_1 + a_3)d(x_1, x_3) + a_5d(x_2, x_3) + (1 - a)\Delta] \\ & \leq \frac{1}{1 - a_2 - a_4} [(a_1 + a_3)d(x_1, x_2) + (a_1 + a_3 + a_5)d(x_2, x_3) + (1 - a)\Delta]. \end{aligned} \tag{30}$$

One gets from (30)

$$\begin{bmatrix} d(x_2, x_3) \\ d(x_3, x_4) \end{bmatrix} \leq \begin{bmatrix} 0 & 1 \\ \frac{a_1+a_3}{1-a_2-a_4} & \frac{a_1+a_3+a_5}{1-a_2-a_4} \end{bmatrix} \begin{bmatrix} d(x_1, x_2) \\ d(x_2, x_3) \end{bmatrix} + \begin{bmatrix} 0 \\ \frac{1-a}{1-a_2-a_4} \Delta \end{bmatrix}. \tag{31}$$

Proceed recursively with (31) by defining the sequence $\{x_n\} \subseteq \bigcup_{i \in \bar{p}} X_i$ with initial values x_j , subject to (30) for $j = 1, 2, 3, 4$ and the given arbitrary $i \in \bar{p}$, and a two-dimensional real vector by

$$v_n = \begin{bmatrix} d(x_{n+1}, x_{n+2}) \\ d(x_{n+2}, x_{n+3}) \end{bmatrix}, \quad \forall n \in \mathbf{Z}_+, \tag{32}$$

with initial value $v_1 = \begin{bmatrix} d(x_1, x_2) \\ d(x_2, x_3) \end{bmatrix}$, and a square real 2-matrix A and a two-dimensional vector d defined by

$$A = \begin{bmatrix} 0 & 1 \\ \frac{a_1+a_3}{1-a_2-a_4} & \frac{a_1+a_3+a_5}{1-a_2-a_4} \end{bmatrix}, \quad d = \begin{bmatrix} 0 \\ \frac{1-a}{1-a_2-a_4} \Delta \end{bmatrix}. \tag{33}$$

Then it is possible to write, in a similar way to (31),

$$v_{n+1} \leq Av_n + d, \quad \forall n \in \mathbf{Z}_+, \tag{34}$$

such that for any $x_{n+2} \in X_j$, there is $x_{n+3} \in [Tx_{n+2}]_{\alpha(x_{n+2})} \subseteq X_{j+1}$ with $j = j(n, i) \in \bar{p}$ depending on the given arbitrary initial $i \in \bar{p}$ with $x_1 \in X_i$ and $x_2 \in X_{i+1}$. Thus, one gets from (34)

$$\|v_{np+1}\|_2 \leq \|A\|_2 \|v_{np}\|_2 + \|d\|_2, \quad \forall n \in \mathbf{Z}_+, \tag{35}$$

where $\|d\|_2$ is the ℓ_2 -vector norm of d and

$$\|A\|_2 = \sup_{\|\mu\|_2=1} \left(\frac{\|A\mu\|_2}{\|\mu\|_2} : \mu \in \mathbf{R}^2 \right) = \sup_{\|\mu\|_2=1} (\|A\mu\|_2 : \mu \in \mathbf{R}^2) = \lambda_{\max}^{1/2}(A^T A)$$

is the ℓ_2 (or spectral)-matrix norm of A (which is the induced ℓ_2 -vector norm), where $\lambda_{\max}(A^T A)$ denotes the maximum/real eigenvalue of the (symmetric) matrix $A^T A$ and the superscript T denotes matrix transposition. If $\lambda = \|A\|_2 \in (-1, 1)$, then A is a convergent matrix and then $\|A\|_2^n \rightarrow 0$ as $n \rightarrow \infty$ so that

$$\begin{aligned} \|v_{n+1}\|_2 &\leq \|A\|_2 \|v_n\|_2 + \|d\|_2 \leq \|A\|_2^n \|v_1\|_2 + \|d\|_2 \left(\sum_{i=0}^{n-1} \|A\|_2^{n-i-1} \right) \\ &\leq \|A\|_2^n \|v_1\|_2 + \|d\|_2 \left(\sum_{i=0}^{\infty} \|A\|_2^{n-i-1} - \sum_{i=n}^{\infty} \|A\|_2^{n-i-1} \right) \\ &\leq \lambda^n \|v_1\|_2 + \frac{1-\lambda^n}{1-\lambda} \|d\|_2 \leq \|v_1\|_2 + \frac{\|d\|_2}{1-\lambda} \\ &= \|v_1\|_2 + \frac{1-a}{(1-a_2-a_4)(1-\lambda)} \Delta < \infty, \quad \forall n \in \mathbf{Z}_+. \end{aligned} \tag{36}$$

Now, note that if $\rho \in (-1, 1)$ is the dominant eigenvalue of A , then $\lambda \leq |\rho| < 1$ and then, from (36),

$$\limsup_{n \rightarrow \infty} \|d(x_{n+3}, x_{n+4})\|_2 \leq \limsup_{n \rightarrow \infty} \|v_{n+1}\|_2 \leq \frac{(1-a)\Delta}{(1-a_2-a_4)(1-|\rho|)}. \tag{37}$$

From the definition of the matrix A , its eigenvalues are the roots of its characteristic polynomial $p(z) = z^2 - \frac{a_1+a_3+a_5}{1-a_2-a_4}z - \frac{a_1+a_3}{1-a_2-a_4}$ resulting in

$$z_{1,2} = \frac{1}{2} \left(\frac{a_1+a_3+a_5}{1-a_2-a_4} \pm \left(\left(\frac{a_1+a_3+a_5}{1-a_2-a_4} \right)^2 + 4 \frac{a_1+a_3}{1-a_2-a_4} \right)^{1/2} \right) \tag{38}$$

and $|z_{1,2}| < 1$, and then A is a convergent matrix so that (37) holds, if $a_2 + a_4 + 2(a_1 + a_3) + a_5 < 1$. Property (i) has been proved.

Now, assume that the sets X_i fulfill the constraint $D = D_i = d(X_i, X_{i+1}), \forall i \in \bar{p}$, and that the contractive condition holds with $\Delta = \frac{(1-a_2-a_4)(1-|\rho|)}{1-a} D \geq D$, or equivalently, with

$$\rho = |\rho| = z_2 = \frac{1}{2} \left(\frac{a_1+a_3+a_5}{1-a_2-a_4} + \left(\left(\frac{a_1+a_3+a_5}{1-a_2-a_4} \right)^2 + 4 \frac{a_1+a_3}{1-a_2-a_4} \right)^{1/2} \right) < 1.$$

But note from (38) that $|\rho| \geq \frac{a_1+a_3+a_5}{1-a_2-a_4}$ with the equality occurring if and only if $a_1 = a_3 = 0$. Then, if $\Delta \geq D = D_i, \forall i \in \bar{p}, a_1 = a_3 = 0$, and $|z_{1,2}| \leq z_2 < 1$, then $\lim_{n \rightarrow \infty} \|v_{np+1}\|_2 = D$. This implies that $d(x_{np+3}, x_{np+2}) \rightarrow 0$ and $d(x_{np+1}, x_{np+2}) \rightarrow D$ as $n \rightarrow \infty$ from (32), since for the definition of the real sequences $\{v_n\}$ and $\{x_n\}$, x_{np+2} and x_{np+3} are both in some set X_{i+1} , while x_{np+1} and x_{np+2} , and x_{np+3} and x_{np+4} are, respectively, in the sets X_i and X_{i+2} , adjacent to X_i , for any given initial points $x_1 \in X_i$ and $x_2 \in X_{i+1}$ for any arbitrary $i \in \bar{p}$. This leads directly to the proof of Property (ii). See also the proof of Theorem 8(iii)-(iv) concerning the convergence of the sequence to a set of α -fuzzy best proximity points and a unique α -fixed point if $D = 0$. □

Example 15 Example 13 can also easily be monitored via Theorem 14 via the modified contractive constraint (22) with $a_4 = a_5 = 0$.

The subsequent definition extends Definition 1 in the sense that an extended p -cyclic fuzzy mapping of domain restricted X_j has its image in $X_j \cup X_{j+1}$ for any $j \in \bar{p}$.

Definition 16 Let $p(\geq 2) \in \mathbf{Z}_+$ and let X_i be nonempty subsets of a nonempty abstract set $X, \forall i \in \bar{p}$, where (X, d) is a metric space. A mapping $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ is said to be an extended p -cyclic fuzzy mapping from $\bigcup_{i \in \bar{p}} X_i$ to $F(\bigcup_{i \in \bar{p}} X_i)$ if:

- (a) $T : \bigcup_{i \in \bar{p}} X_i | X_j \rightarrow F(X_j \cup X_{j+1}); \forall j \in \bar{p}$,
- (b) there is $\alpha(x) \in (0, 1]$ such that the $\alpha(x)$ -level set $[Tx]_{\alpha(x)} \in CB(X_i \cup X_{i+1}); \forall x \in X_i, \forall i \in \bar{p}$.

Theorem 17 Let $p(\geq 2) \in \mathbf{Z}_+$ and let X_i be nonempty subsets of a nonempty abstract set X with $\text{diam}(X_i) \geq D$ and $d(X_i, X_{i+1}) = D; \forall i \in \bar{p}$, where (X, d) is a complete metric space. Let $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ be an extended p -cyclic fuzzy mapping with X_i being closed, $\forall i \in \bar{p}$. Assume that the following point-dependent contractive constraint extended from (1) holds:

$$\begin{aligned}
 &H([Tx]_{\alpha(x)}, [Ty]_{\alpha(y)}) \\
 &\leq a_{1(x, [Tx]_{\alpha(x)})} d(x, [Tx]_{\alpha(x)}) + a_{2(y, [Ty]_{\alpha(y)})} d(y, [Ty]_{\alpha(y)}) \\
 &\quad + a_{3(x, y)} d(x, y) + (1 - a) \mu(x, y) D;
 \end{aligned} \tag{39}$$

$\forall x \in X_i, \forall y \in X_{i+1}, \forall i \in \bar{p}$, and some $\Delta \in \mathbf{R}_+$ where $a_{i(i)} \geq 0$ for $i = 1, 2, 3$, and

$$\mu(x, y) = \begin{cases} 0 & \text{if } (x, y) \in X_i \times X_{i+1}, \\ 1 & \text{if } x, y \in X_i \end{cases} \tag{40}$$

for any given $i \in \bar{p}$. Then the following properties hold:

- (i) For any arbitrarily given $i \in \bar{p}$, a sequence $\{x_n\} \subset \bigcup_{i \in \bar{p}} X_i$ can be built for any given $x = x_1 \in X_i, y = x_2 \in [Tx_1]_{\alpha(x_1)} \subseteq X_{i+1}$ such that $x_{np+j} \in [Tx_{np+j-1}]_{\alpha(x_{np+j-1})} \subseteq X_{i+j-1}; \forall j \in \bar{p}, \forall n \in \mathbf{Z}_{0+}$, which fulfills

$$\lim_{n \rightarrow \infty} d(x_{(n+1)p+j+2}, x_{(n+1)p+j+1}) = D; \quad \forall j \in \mathbf{Z}_{0+} \tag{41}$$

for any $q \in \mathbf{Z}_{0+}$ if $\lim_{n \rightarrow \infty} (\prod_{j=0}^n \prod_{m=i}^{p+i} \prod_{\ell=1}^{k_{jm}} [K_{jm\ell}]) = 0$, where

$$K_{jm\ell} = \frac{a_{1jm\ell} + a_{3jm\ell}}{1 - a_{2jm\ell}}; \quad \ell \in k_{jm}, j \in \mathbf{Z}_{0+}, m \in \bar{p}, \tag{42}$$

where the integer subscripts

$$\ell \in \bar{k}_{jm}, \quad k_{jm} (\leq \bar{k} < \infty) \in \mathbf{Z}_{0+}, \quad j (\leq n) \in \mathbf{Z}_{0+}, \quad m \in \bar{p}, \tag{43}$$

are, respectively, the indicator of each current iteration within the set X_m , the number of consecutive iterations at the j th tour over the cyclic disposal in the X_m set before jumping to

the X_{m+1} set, the tour counter of completed tours over the cyclic disposal, and the indicator of the current X_m set for the iteration.

(ii) If Property (i) holds, then Theorem 8(iii)-(iv) hold.

Proof Define

$$K(x, y, [Tx]_{\alpha(x)}, [Ty]_{\alpha(y)}) = \frac{a_1(x, [Tx]_{\alpha(x)}) + a_3(x, y)}{1 - a_2(y, [Ty]_{\alpha(y)})}. \tag{44}$$

Note that the contractive constraint (39)-(40) leads, in a similar way to (8) in Theorem 8, to the following inequality:

$$\begin{aligned} & d(x_{(n+1)p+q+2}, x_{(n+1)p+q+1}) \\ & \leq \left(\prod_{j=0}^n \prod_{m=i}^{p+i} \prod_{\ell=1}^{k_{jm}} [K_{jm\ell}] \prod_{m=i}^{\delta+i-1} \prod_{\ell=1}^{k_{jm}} [K_{n+1,m\ell}] \prod_{\ell=1}^{\hat{k}_{n+1,\delta+i}} [K_{n+1,\delta+i,\ell}] \right) (d(x_1, x_2) - D) + D; \\ & \forall n \in \mathbf{Z}_{0+}, j \in \bar{p}, \end{aligned} \tag{45}$$

for some integer $0 \leq \delta \leq p$, where $0 \leq \hat{k}_{n+1,m} = k_{n+1,m}$ for $i \leq m \leq \delta + i - 1$, $0 \leq \hat{k}_{n+1,\delta+i} \leq k_{n+1,\delta+i}$, $n \in \mathbf{Z}_{0+}$ is the last completed tour of the cyclic disposal, and

$$q = q(i, n, \delta, k_{0m}, \dots, k_{nm}, \hat{k}_{n+1,\delta+i}) = \sum_{j=0}^n \sum_{m=i}^{p+i} k_{jm} + \sum_{m=i}^{\delta+i-1} k_{n+1,m} + \hat{k}_{n+1,\delta+i}, \tag{46}$$

$$K_{jm\ell} = \frac{a_{1jm\ell} + a_{3jm\ell}}{1 - a_{2jm\ell}}; \quad \ell \in k_{jm}, j \in \mathbf{Z}_{0+}, m \in \bar{p}. \tag{47}$$

Note that $k_{jm} \leq \bar{k} < \infty$; $\forall m \in \bar{p}, \forall j \in \bar{n} \cup \{0\}$ and $k_{n+1,j+i} \leq \bar{k} < \infty$ for $j \in \overline{\delta-1} \cup \{0\}$ if $n < \infty$. Now, note also that $\hat{k}_{n+1,\delta+i} \leq \bar{k} < \infty$ if $n \rightarrow \infty$, since the number of sequence tours (tour counter) through the cyclic disposal tends to infinity. It turns out that $\lim_{n \rightarrow \infty} d(x_{(n+1)p+q+2}, x_{(n+1)p+q+1}) = D$ for any $q \in \mathbf{Z}_{0+}$ as $n \rightarrow \infty$ if

$$\lim_{n \rightarrow \infty} \left(\prod_{j=0}^n \prod_{m=i}^{p+i} \prod_{\ell=1}^{k_{jm}} [K_{jm\ell}] \right) = 0.$$

Property (i) has been proved. The proof of Property (ii) is straightforward from Property (i) by similar arguments to those used in the proofs of Theorem 8(iii)-(iv). \square

Note that Theorem 17 does not require all the elements of the contractive sequence (42) to be less than 1. The following result is proved for the case when the built sequences are permanent on some of the subsets of the cyclic disposal.

Corollary 18 *The following properties hold under the assumptions of Theorem 17:*

(i) *Theorem 17(i) still holds if there is a finite number n_0 of complete tours in the cyclic disposal and $\lim_{n \rightarrow \infty} (\prod_{\ell=1}^{\hat{k}_{n_0+1,\delta+i}} [K_{n_0+1,\delta+i,\ell}]) = 0$ for some integer $0 \leq \delta \leq p$ with the sequence $\{x_n\}$ being permanent at $\{X_{i+\delta}\}$. Then $\lim_{n \rightarrow \infty} d(x_{(n+1)p+j+2}, x_{(n+1)p+j+1}) = 0; \forall j \in \mathbf{Z}_{0+}$.*

(ii) *The sequence converges to a unique $\alpha = \alpha(x^*)$ -fuzzy fixed point x^* of $T : \bigcup_{i \in \bar{p}} X_i \rightarrow F(\bigcup_{i \in \bar{p}} X_i)$ allocated in $[Tx^*]_{\alpha(x^*)} \subseteq X_{i+\delta}$.*

Proof Property (i) follows from (45) for $n \leq n_0 < \infty$ and $\hat{k}_{n_0+1, \delta+i} \rightarrow \infty$. Property (ii) follows from Property (i) since (X, d) is complete and $[Tx]_{\alpha(x)}$ is closed for any $x \in \bigcup_{i \in \mathbb{P}} X_i$ in a similar way to the proof of Theorem 8(iv). \square

Example 19 Define the linear metric space (X, d) with X being the union of closed real intervals $X_1 = [-r_1, -D/2]$, $X_2 = [D/2, r_2]$ subject to

$$r_1 > 3D/2 \geq 0, \quad \min(r_1, r_2) > 0, \quad \max(r_1, r_2) < +\infty,$$

and which have mutual and Pompeiu-Hausdorff distances $d(X_1, X_2) = D$ and $H(X_1, X_2) = D + \max(r_1, r_2)$, respectively. Consider some extended 2-cyclic fuzzy mapping $T : X_1 \cup X_2 \rightarrow F(X_1 \cup X_2)$ whose restrictions of domain are to the two subsets X_1 and X_2 fulfill $T : X_1 \cup X_2 | X_1 \rightarrow F(X_1 \cup X_2)$, $T : X_1 \cup X_2 | X_2 \rightarrow F(X_1)$. Such a map is defined in such a way that it constructs iterative sequences which are ordered with two consecutive elements $x_n, x_{n+1} \in [Tx_n]_1 \subset X_1$ and the next one $x_{n+2} \in [Tx_{n+1}]_1 \subset X_2$, and which satisfies the constraints:

$$\begin{aligned} d(x_{n+1}, x_n) &\leq \rho d(x_n, x_{n-1}) \quad \text{if } x_n, x_{n+1} \in [Tx_n]_1 \subset X_1, \\ d(x_{n+2}, x_{n+1}) &\leq Kd(x_n, x_{n-1}) + (1 - K)D \quad \text{if } x_{n+2} \in [Tx_{n+1}]_1 \subset X_2, \end{aligned}$$

for $n \in \mathbf{Z}_+$ subject to $K^2 \rho < 1$. Note that either K or ρ (but not both of them) cannot be less than unity. Since the 1-level sets are nonempty and contain the points, identified with their associated crisp sets, we can consider $F(X_1)$ and $F(X_2)$ as approximate quantities [22, 28], since X_1 and X_2 are compact and convex, and such crisp sets, equivalently as points, obtained from a maximum defuzzifier [34], since there exists a compact $[Tx]_1 (\neq \emptyset) \subseteq [Tx]_{\alpha(x)}$ for any $x \in X_1 \cup X_2$ and any $\alpha(x) \in (0, 1]$. Assume that $x_1, x_2 \in X_1$ and $x_3 \in X_2$, and then $x_{2n} \in [Tx_{2n-1}]_1 \subset X_1$, $x_{2n+1} \in [Tx_{2n}]_1 \subset X_1$, $x_{2n+2} \in [Tx_{2n+1}]_1 \subset X_2$; $\forall n \in \mathbf{Z}_+$, and one gets

$$\begin{aligned} d(x_{2n+1}, x_{2n}) &\leq (K^2 \rho)^n d(x_1, x_2) + (1 - K^n)D, \\ d(x_{2n+2}, x_{2n+1}) &\leq Kd(x_{2n+1}, x_{2n}) + (1 - K)D, \\ \lim_{n \rightarrow \infty} d(x_{2n+1}, x_{2n}) &= \lim_{n \rightarrow \infty} d(x_{2n+2}, x_{2n+1}) = D. \end{aligned}$$

If $x_1 \in X_2$ and $x_2, x_3 \in X_1$, $x_{2n} \in [Tx_{2n-1}]_1 \subset X_2$, $x_{2n+1} \in [Tx_{2n}]_1 \subset X_1$, and $x_{2n+2} \in [Tx_{2n+1}]_1 \subset X_1$; $\forall n \in \mathbf{Z}_+$, the same conclusion for the distance limits as above follows. In both cases, sequences converging to the limit cycle $\{-3D/2, -D/2, D/2\}$ are obtained for any initial conditions $x_1, x_2 \in X_1$ or $x_1 \in X_2, x_2 \in X_1$. All the sequences are not necessarily converging to the above limit cycle, in general, unless it be assumed that $T : X_1 \cup X_2 \rightarrow F(X_1 \cup X_2)$ is such that $[Tx]_{\alpha(x)} = [Tx]_1$; $\forall x \in X_1 \cup X_2$.
